

DIRECTORY OF OXFORD HOUSES IN WASHINGTON STATE

(Updated August 25, 2010)

What is an Oxford House?

Oxford Houses are an affordable, alcohol- and drug-free housing option for individuals in recovery. The houses are independent and peer run, and residence is voluntary. Houses are located in rented single-family homes. In Washington State, as of September 2010, there are 217 houses with 1,802 beds covering 21 counties. Oxford House, Inc., will charter Oxford Houses if they agree to follow standardized procedures.

Individuals typically enter an Oxford House after completing a chemical dependency treatment program. Individuals living in a house are expected to participate in a recovery program in the community during their residence. Individuals can live in an Oxford House for as long as they want, provided they follow house rules.

What Are the Basic House Rules for Residents?

- Houses operate democratically, electing house officers who serve six-month terms.
- Houses are financially self-supporting; members split house expenses, which average \$275 to \$450 per person per month.
- Any resident who relapses must be immediately expelled.

Who is Eligible To Be a Resident of an Oxford House?

It is recommended, but not required, that individuals complete a treatment program and be alcohol and drug-free for ten days or more (longer is preferred) at the time of application. They must also be willing to accept the house rules and expectations, and be able to pay their equal share of household expenses.

How Does Someone Apply to Be a Resident?

If an individual is interested in living in an Oxford House, they can apply directly to the house of their choice. If there are vacancies, an interview will be scheduled. The interview with an applicant involves all members of the house. Eighty percent of the house members must vote to accept the applicant as a roommate.

What Role Do Chemical Dependency Counselors Have?

Chemical dependency counselors are the primary source of referrals to Oxford Houses, and therefore have a role in pre-screening potential residents. Getting a workable match between an individual and a house is important, as residents who are disruptive and not serious about recovery can cause serious problems for a house. Counselors can be a big help, if they take the time to pre-screen potential referrals. Counselors are offered the following criteria for use:

- Is the individual willing and able to live in a shared housing arrangement?
- Has the individual shown reasonable behavior in a treatment setting?
- Has the individual thought about her/his own recovery and is she/he committed to recovery?
- Does the individual have a recovery plan when she/he finishes treatment?
- Suggest that your client think about Oxford House as a living situation for a few days before completing an application. Applicants should consider if Oxford House is a fit for them. Applications are often available at treatment agencies. They can also be obtained by calling an Oxford House directly. The Alcohol/Drug 24-Hour Help Line maintains a directory of Oxford Houses.
